## Claims Legal Services

#### **Topic**

This Action Item seeks Board approval for \$50 million in additional spend authority under the Claims Legal Services contracts, for a total of \$400 million authorized spend. This approval is requested for expenditures across the initial panel contracts (RFP 21-0012) approved by the Board on December 15, 2021, and the supplemental panel contracts (RFP 22-0021) approved by the Board on March 29, 2023.

This Action Item also seeks Board approval to enter contracts with new firms as appropriate at Citizens' discretion when a senior attorney or attorneys handling matters for Citizens leaves a firm with whom Citizens is currently contracted and moves to a firm that is not on Citizens' contracted panel. Contracts executed under this authority will be governed by the Board's approval of the other panel contracts including the shared spend limit. This approval is requested for the Claims Legal Services panel (RFPs 21-0012 and 22-0021) and the General Corporate Legal Services panel (RFP 22-0013) approved by the Board in September 2022.

### **History**

Citizens regularly engages outside law firms to provide representation in claims-related pre-suit and litigation matters. Citizens currently utilizes a panel comprised of one-hundred and twelve (112) outside defense firms to provide legal representation in the following four (4) claims-related Service Areas:

- First Party Property,
- · Third Party Liability,
- Subrogation, and
- · Appeals.

The current Claims Legal Services contracts were procured under RFP 21-0012 and RFP 22-0021. The Board approved the initial panel contracts at a December 15, 2021 Board of Governors meeting. At that meeting, Citizens requested \$500 million in spend authority based on the estimated total contract amount over the initial five (5) year term. The Board approved \$50 million in initial authorized spend. This approval included a request that Staff provide ongoing litigation updates as justification for additional spend requests/authorization, and to facilitate discussion and seek solutions to the ongoing litigation concerns. The Board approved spend increases of \$50 million at the July 13, 2022 and December 22, 2022 Board of Governors meetings. At the March 29, 2023 Board of Governors meeting, the Board approved the supplemental panel contracts and an additional \$50 million in contract spend across the initial and supplemental panel contracts. The Board approved three additional spend increases of \$50 million at the September 27, 2023, December 6, 2023, and April 10, 2024 meetings, bringing the total Board approved amount to \$350 million.

As of August 1, 2024, Citizens has incurred approximately \$333 million in spend under the approved Claims Legal Services contracts. Citizens forecasts that spend will likely exceed the approved \$350 million prior to the December 2024 Board of Governors meeting. Citizens continues to maintain a high volume of claims-related litigation in terms of both new and total pending lawsuits. As of August 1, 2024,

the number of pending claims-related lawsuits is approximately 17,000. In addition to pending lawsuits, Citizens' policy-in-force count continues to rise, with PIF count totaling 1,213,495 as of July 1, 2024.

With the continuing high volume of (1) new claims-related litigation, (2) overall amount of pending claims-related litigation and (3) policy-in-force counts, Citizens anticipates that spend under the Claims Legal Services contracts will not abate for the foreseeable future. In addition to these factors, it should be noted that the contracts allow for increased rates for panel counsel beginning in February 2025.

A summary of the monthly contract spend to date is provided below:

Based on the above, Staff is requesting approval for an additional \$50 million in spend authority across the initial and supplemental Claims Legal Services contracts to fund these services through the end of 2024. Additional spend authority will be requested prior to exhaustion of previously approved amounts or in the event of a change in circumstances caused by large storm events or other changes to the market.

This Action Item also seeks approval to contract with new firms as appropriate when a previously vetted senior attorney or attorneys handling matters for Citizens leaves a firm with whom Citizens is currently contracted and moves to a firm that is not on Citizens' contracted panel. At the present, when this situation occurs, Citizens is limited in its ability to access that attorney's legal services, since that attorney is no longer on Citizens' panel. Not only does this limit Citizens' options for assigning future matters, but it can cause disruption and/or delays in Citizens' handling of pending matters. Citizens typically redirects a departing attorney's work to other attorneys at the same firm or to other contracted firms.

This Action Item provides staff flexibility when addressing attorney departures from firms on the panel. Where a senior level attorney has demonstrated high performance at competitive rates, it is often in Citizens' best interest to continue to receive services from that attorney under a contract with their new firm. In many instances, keeping matters with the departing attorney provides continuity and cost savings. This requested authority would only be utilized at Citizens' discretion and with attorneys who have been vetted and demonstrated future value by way of their past relationship with Citizens while working at a contracted firm.

This approval for additional contracts is requested for the Claims Legal Services panel (RFPs 21-0012 and 22-0021) and the General Corporate Legal Services panel (RFP 22-0013). The Board approved the General Corporate Legal Services panel of seventeen firms in September 2022 for an amount not to exceed \$8,400,000. The General Corporate Legal Services panel includes five practice areas: Administrative and Government Law, Civil Litigation, Class Action Defense, Employment Law, and Transactional Law.

New contracts executed under this authority will be governed by the Board's approval of the other panel contracts including the shared spend limit. Additional contracts entered pursuant to this authority are not expected to increase total spend under either panel.
