



**AMENDMENT No. 4 – NAME CHANGE TO CONTINGENT AGREEMENT
FOR INDEPENDENT ADJUSTING SERVICES - LITIGATED
WITH ALACRITY PARENT, LLC
DBA ALACRITY SOLUTIONS GROUP, LLC**

This document hereby amends Agreement No. 17-17-0002-13 (the "Agreement") by and between **Citizens Property Insurance Corporation** ("Citizens") and **Worley Parent, LLC dba Alacrity Solutions Group, LLC** ("Vendor"), (now known as **Alacrity Parent, LLC dba Alacrity Solutions Group, LLC**), (collectively, the "Parties").

For sufficient, good and valuable consideration, the Parties hereby agree to amend the Agreement as follows:

1. Vendor Name Change (the "Name Change"):

NEW VENDOR LEGAL BUSINESS NAME:	Alacrity Parent, LLC dba Alacrity Solutions Group, LLC

2. The Name Change does not in any way affect the relationship or obligations of the Parties in regard to the Agreement. Alacrity Parent, LLC dba Alacrity Solutions Group, LLC shall take the place of Worley Parent, LLC dba Alacrity Solutions Group, LLC as referenced in the Agreement.

The sections of the Agreement that are not expressly modified or replaced by this Amendment shall remain in effect pursuant to their terms. In the event that any of the provisions of the Amendment are inconsistent or conflict with any provisions of the Agreement, the inconsistent or conflicting provisions of this Amendment shall control, but only to the extent that such provisions are inconsistent or conflicting with the Agreement.
